1. All requests for use of Department of Archives and Special Collections materials, whether in publications, motion pictures, videos, or other projects will be considered on a case-by-case basis.
2. It is the responsibility of the applicant to obtain any required copyright permissions from the copyright holder, which in some instances may be Loma Linda University.
3. It is the policy of the Department of Archives and Special Collections to assess a fee for some uses of material from its collections. Such fees are assessed on a case-by-case basis and are intended to offset a small part of the Center's costs associated with processing, preserving, and servicing of its collections.
4. Use fees cover non-exclusive, one-time use only unless otherwise indicated and are to be paid in advance. They are assessed in addition to any duplication costs.
5. The following credit line must be used:
